Grant monies are intended to assist our members in reducing their daily risks exposures and applying effective risk management and loss control techniques. Many grant submissions were received and processed during this first grant cycle.

Notifications of grant awards or non-award requests is expected to be made within sixty (60) days of your application due date. Members that receive grant awards will be recognized at the MTA January conference during the Par Plan Fun Night held on Wednesday, January 25, 2012.

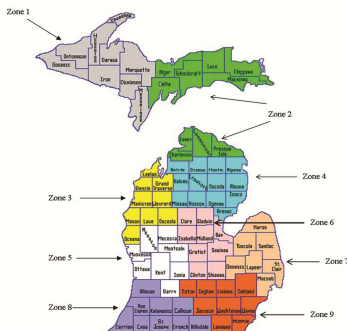
