Don't Let Winter Wreak Havoc

While properties in Michigan's climate can't escape the yearly onslaught of wind, ice, rain, and snow, winterizing programs can work proactively to shield buildings from winter's weather. Because each structure's situation, climate, usage, and components are different, with the right protective and reactive maintenance programs in place, winter need not take a significant toll on building integrity.

With a modest expenditure of energy toward planning and prevention, you can stay ahead of the weather and avoid shelling out for serious repairs come spring. Invest a few hours developing your winterizing program checklist and log book, which can act as a quick reference guide as you prepare each year for the winter months. Collect and store information on maintenance evaluations, planning, repairs, and methods. Use photographs and list needed repairs so that these can be scheduled and completed before the cold weather.

The trick is to plan ahead, so that liability concerns and emergency situations don't force hasty decisions. With the right preparation, winter maintenance can be simple, cost effective, and efficient.

Tips for winterizing

Freezing pipes: Frozen water pipes can cause water pressure build-up between the ice blockage and the closed faucet at the end of a pipe, which leads to pipes bursting.

- Set the heat on un-occupied buildings no lower than 55 degrees and perform periodic building checks
- Fit exposed pipes with insulation sleeves or wrapping to slow heat transfer
- Seal cracks and holes in outside walls and foundations near water pipes with caulking



Ice Dams: An ice dam is an accumulation of ice at the lower edge of a sloped roof, usually at the gutter. When interior heat melts the snow on the roof, the water will run down and refreeze at the roof's edge, where temperatures are much cooler.

- Keep the roof/attic well ventilated
- Keep the attic floors well insulated to minimize the amount of heat rising through the attic from within the building.
- Clean the gutters – clogged drains can form ice dams

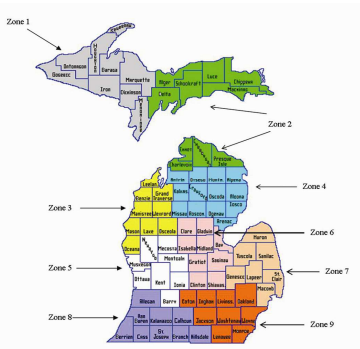

I work for you....

A few of you may know me by name, or maybe by face, but many of you may not know me at all. My initial contact with any given member of the Par-Plan is likely to be when a lawsuit first arrives at the offices of Midwest Claims Service, Inc. (“Midwest”), where I work. Upon receipt of the lawsuit, I will place a call to the member contact to let you know that the matter has been assigned to me to manage and to advise you of the name of the attorney (chosen from our Michigan appointed counsel roster) who has been assigned to defend you in the lawsuit. Although much of your communication from this point forward is between you and appointed defense counsel, you are always welcome and encouraged to contact me to discuss any questions or concerns you may have. It is important that you have an understanding of the coverage provided to you, as well as an overall knowledge of the lawsuit that we are defending for you.

As a Vice President assigned to the Par-Plan program, I am responsible for overseeing the litigation filed against all Par-Plan members. My responsibilities include reviewing and analyzing coverage, establishing and monitoring the files’ financial reserves, communicating with appointed defense counsel on case strategy and authorizing the settlement of the lawsuits that we defend on your behalf.

In addition to managing the litigation for the Par-Plan, I also communicate with your insurance agent to answer questions or concerns they may have relative to liability issues and coverage matters. Additionally, I report to the Par-Plan Board of Directors at its’ Quarterly and Annual Board meetings to advise them of high exposure cases within the program. Although I spend much of my time in the Midwest office, I also travel throughout the state of Michigan attending facilitations and settlement conferences on Par-Plan matters.

Help me work more efficiently for you. In the event you are sued, please do the following:

Forward the lawsuit to claims@midwestclaims.com immediately upon being served. I also recommend that you forward a copy to your insurance agent and Township attorney as well.

Make sure that all Township Board Members and Township employees know what a Summons & Complaint is so that if he or she is served with a Summons & Complaint (a.k.a. a lawsuit); they know the importance of forwarding the lawsuit to the necessary parties immediately.

Please get our approval or approval of defense counsel before you talk to anyone about the lawsuit, especially news reporters.
